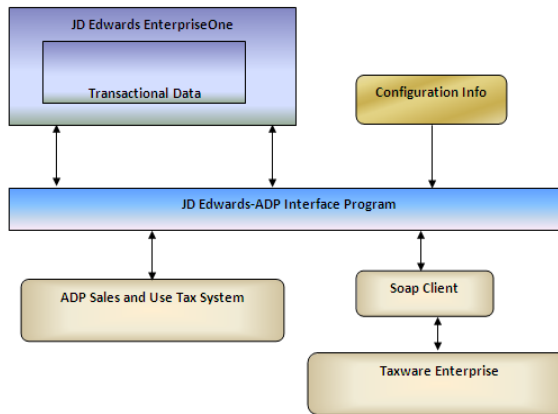

### Integration Details

Taxware Enterprise integrates with JD Edwards EnterpriseOne Release 9.0 (JD Edwards EnterpriseOne Accounts Payable, JD Edwards EnterpriseOne Accounts Receivable, JD Edwards Procurement and Subcontract Mangement, and JD Edwards EnterpriseOne Sales Order Management) for tax jurisdiction lookup and tax calculation. The Taxware Enterprise interface is also a SOAP service that wraps the Taxware Enterprise system for geocode lookup and tax calculation. The integration between JD Edwards EnterpriseOne and Taxware Enterprise is used to transfer selected JD Edwards EnterpriseOne components to Taxware Enterprise and then return tax information to the JD Edwards EnterpriseOne system.
