resources. This integration uses Oracle Data Integrator scenarios to load data into the Compliance Tax Solution environment.

After the information is uploaded into the Compliance Tax Solution interface, any information exchange between Compliance Tax Solution and Oracle Data Integrator will be allowed. The process of validating audit information occurs when the data is being uploaded to the Compliance Tax Solution interface and after that, data will be recorded into Compliance Tax Solution database. At the end of interface integration on production base, the system will provide a report on errors found during the auditing process, thus allowing the user to correct those errors.

Below are some developed interfaces:

- General registers (participants, units of measure, items products/services, and nature of operation)
- System user (uses the same Oracle user login)
- Financial data (chart of accounts, cost centers, historical standards, accounting balances, and accounting monthly releases)
- Fiscal third-party documents (in operation)
- Inventory of products
- Company records and organizational units
- Online issue of electronic invoice
- Online issue of electronic service invoice
