PayMatch automates payroll testing that occurs when an Oracle's PeopleSoft tax update, change in benefits, organizational change, or application upgrade is applied. Online review pages display payroll discrepancies in 10 comparison categories, including earnings, deductions, and taxes, which may have resulted from the system changes. In addition, comparison reports and custom queries can be processed to audit the results. PayMatch allows you to parallel test your payroll in less time and with more accuracy. The application was specifically designed to run within PeopleSoft Human Capital Management and PeopleSoft Payroll. It is easy to use and provides a flexible and robust testing framework.

When Should You Use PayMatch?

- **Implementations**—Use PayMatch when first implementing PeopleSoft Payroll, or when converting a separate organization from any payroll application to PeopleSoft Payroll.
- **Upgrades/Updates**—Use PayMatch to verify that the upgrade process did not inadvertently affect payroll processing.
- **Tax Updates**—Test the expected changes introduced by a tax update. Verify that unexpected payroll changes didn't occur to your payroll by quickly testing 100 percent of employees' paychecks.

- Time Reporting Changes—Anytime you change the way you capture and report time, use PayMatch to validate resulting payroll data accuracy.
- Regular Payroll Validation—Compare the current pay period to the prior pay period to identify significant changes in employee paychecks. Use this process as your regular payroll audit routine and have confidence that errors are being caught before the paychecks are distributed.

Integration Details

PeopleSoft calculated payroll results are sent one way via an SQR from PeopleSoft into PayMatch. PeopleSoft Payroll remains the system of record. No data is sent back to PeopleSoft or updated in PeopleSoft delivered tables. Only PayMatch compare tables are inserted and updated. Uses Read Only/Select Access to PeopleSoft tables to load old/new PeopleSoft calculated payroll results into PayMatch. With the PeopleSoft Payroll results loaded into PayMatch, the differences between the old baseline payroll and the new payroll can be analyzed. PayMatch has the flexibility of up to 10 compare types available for customer selection and review.
