If organizations are to deliver the fast and accurate financial close required by stakeholders and regulatory bodies they need to be able to control and improve the entire 'extended' financial close process. While doing this, organizations also need to adhere to good governance practices and be transparent. Leading organizations recognize that the 'close' begins with sub ledgers and ends with the delivery of statutory filings and therefore are adopting integrated financial close solutions that address this entire process. In fact, they are going further by integrating with their Governance, Risk and Compliance (GRC) solutions to ensure the finance department is not just fast but applies governance and is fully transparent along the way. This helps organizations create a finely tuned and well oiled process that delivers a truly world class financial close.





Oracle Hyperion Financial Management is a financial consolidation and reporting application that supports global accounting and statutory reporting requirements including intercompany eliminations, multicurrency translations, and minority interest calculations. Standards supported include US GAAP, IFRS, and local statutory requirements. It adds value to single or multi-instance ERP environments, consolidating and reporting financial as well as non-financial information needed for sustainability reporting and other requirements.

Oracle Hyperion Financial Close Management is a centralized, web-based application that supports the management of period-end close activities, including account reconciliation and the collection of supplemental data across the extended financial close cycle. It helps manage and automate any task associated with the extended financial close.

Oracle Hyperion Financial Data Quality Management is a packaged solution for integrating data from source systems that can be managed and operated by finance users. It helps develop standardized financial data management processes with a guided workflow user interface. Both financial and non-financial information can be collected and consolidated so sustainability reporting can be undertaken along-side financial reporting with the same degree of accuracy and auditability.

Oracle Hyperion Financial Reporting is an end user oriented, production reporting tool that turns enterprise data into operational insights by creating book-quality financial reports in a variety of formats for a wide range of audiences.

Oracle Hyperion Smart View for Office provides seamless integration with Microsoft Excel, Word and PowerPoint for those who prefer to use the familiar Microsoft Office interface for data entry, reporting and analysis.

Oracle Essbase Analytics Link for Hyperion Financial Management enables the delivery of effective management and financial analytic reporting to a broad user community. It allows users to create and automatically populate Oracle Essbase cubes with financial results, which can be combined with operational information and accessed by managers through a variety of reporting tools.

The suite also includes a restricted use license for **Oracle Essbase** to enable management reporting in conjunction with the planning applications. Additional modules that can be added to the suite include;

Featuring deep integration with existing Oracle financial reporting tools, it is the easiest and most straight forward approach to XBRL reporting for Oracle's enterprise performance management and ERP customers.

Oracle Financial Management Analytics integrates data from Oracle Hyperion Financial Management and Oracle Hyperion Financial Close Management to provide senior finance executives with visibility and insight into the status of the close process, as well as their financial results.

Oracle Hyperion Data Relationship Management is a best-of-breed application used to manage complex, hierarchical enterprise dimensions in a unified environment, and to align those dimensions across a range of operational, transactional and analytical systems.

Oracle Insurance Quantitative Management and Reporting for Hyperion Financial Management is a flexible reporting solution for Solvency II as specified by the European Insurance and Occupational Pensions Authority (EIOPA).
