Race to Certification Challenge

OFFICIAL RULES

BY REGISTERING FOR THIS CHALLENGE, YOU FULLY AND UNCONDITIONALLY AGREE TO COMPLY WITH ALL OF THE TERMS AND CONDITIONS BELOW. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS AND CONDITIONS, DO NOT REGISTER FOR THIS CHALLENGE.

1. DESCRIPTION OF THE CHALLENGE:

Oracle University is launching a free training and certification promotion for OCI between 01-Jun-2023 and 30-Sept-2023, called 'Race to Certification'. This challenge is open to anyone wanting to learn and certify on OCI technologies.

Participants can earn badges and win prizes as they complete courses and certification exams.

Participants are required to complete certain criteria such as taking online digital courses on MyLearn, attending an Oracle University live session and passing certification exams in order to win prizes in the Race to Certification Challenge. There are 3 sectors in the race, and prizes are awarded as participants complete each sector in the Race to Certification. All participants who successfully complete the criteria for Sector 1, Sector 2 and Sector 3 will receive a special Oracle University Community digital Badge for each sector completed. The first 300 participants to successfully complete Sector 2 with the highest cumulative exam score, will receive an Oracle branded cap. The first 300 participants to successfully complete Sector 3 with the highest cumulative exam score, will receive an Oracle branded jacket. Oracle is the sponsor of the Challenge.

2. ELIGIBILITY:

This Challenge is limited to all registered participants of the Free Oracle Certification for OCI promotion who are 18 years of age or older, and the age of majority in entrant's state, province, or territory as of the time of the Entry.

Persons in any of the following categories are not eligible to participate or win the prize(s) offered in this Challenge: (a) persons who are employees or agents of Oracle, its affiliates, subsidiaries, and their service agencies and independent contractors; (b) persons who are or were engaged in the development, production, distribution of materials, prizes, or Challenge of winners for this Challenge; (c) persons who are immediate family (defined as spouse, parent, sibling or child, regardless of where they reside) of, or anyone who resides in the same household as, any person in either of the preceding categories; (d) residents of the province of Quebec, Canada, the country of Italy, the Russian Federation, Belarus, Venezuela or any country under U.S. embargo during the Entry Period or at the time of Challenge; (e) employees, officers, or officials of any government entity

The Challenge begins at 12:00 a.m. GMT on June 1, 2023 and ends at 11:59 p.m. GMT on September 30, 2023 (the Entry Period).

Sponsors clock is the official time clock for the Challenge. IMPORTANT NOTICE TO PARTICIPANTS: EACH PARTICIPANT IS RESPONSIBLE FOR DETERMINING THE CORRESPONDING TIME ZONE IN PARTICIPANT'S RESPECTIVE GEOGRAPHICAL LOCATION. Activations prior to or after the Entry Period will be disqualified.

4. CONDITIONS OF ENTRY:

Participants must follow these steps to activate their access to the free promotion:

- Free Certification for OCI
- Select a Learning Path on oracle MyLearn
- Login and activate using an Oracle Single Sign On
- Accept the Terms & Conditions for the Race to Certification Challenge
- Start Learning & Certifying

Each activation into the promotion will be considered one Entry. Entries that do not comply with these Official Rules will be disqualified. All information collected from Entries shall be deemed collected and evaluated in the United States.

Alternative methods of entry are not accepted. Duplicate entries will be deleted and incomplete activations will not be considered. An entry in the challenge is deemed made by the authorized account holder of the email address submitted at time of activation. The authorized account holder of an email address is defined as the natural person who is assigned an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address. A potential prize winner may be required to provide proof (to Sponsor's satisfaction) that such potential prize winner is the authorized MyLearn account holder of the email address associated with the potentially prize-receiving Entry.
