The shifting demographic landscape in the United States, with over 10,000 individuals entering senior citizenship daily, presents a unique set of challenges in healthcare. The Inflation Reduction Act (IRA), which was enacted to address some of these challenges, made several improvements to the Medicare program by expanding benefits, improving sustainability and also effectively limiting Medicare Part D expenses with a \$2,000 cap on out-of-pocket pharmacy expenses.

Beginning in 2025, this new drug law requires all Medicare prescription drug plans (Medicare Part D plans) — including both stand-alone Medicare prescription drug plans and Medicare Advantage plans with prescription drug coverage — to offer members the option to pay out-of-pocket prescription drug costs in the form of monthly installment payments. This will be of significant help to Part D members who have high cost-sharing earlier in the plan year by smoothening out those expenses over the course of the year.

Billing Challenges and Opportunities for Payers

The IRA introduces both challenges and opportunities for healthcare stakeholders. While it places certain limitations, it also presents a chance for payers and PBMs to offer enhanced flexibility and superior services to their members. However, navigating these changes and complying with other regulatory requirements, demand operational agility and nimbleness, that pose challenges for organizations reliant on legacy financial systems.
