- **The Oracle Collection Tool** is a series of operating system and SQL queries that run in your Oracle estate and collect Oracle product usage information. The outputs are human-readable, so you have visibility into the information shared, and will be analyzed to illustrate what Oracle programs are installed and/or in use.
- **The Global Deployment Matrix** is an online form that gives you guidance on how to catalog and provide an overview of the Oracle programs in use.
