Event terms: Registration, badges, and age limits

Per Oracle rules and regulations, every attendee must register for the conference using their own Oracle.com single sign-on (SSO) login. If an attendee does not have an Oracle.com account already created, they must create one at [Oracle.com](https://www.oracle.com).

Attendees must use their own badge while at the event. Badges are nontransferable and may not be shared on site. Any person found to be in violation of this policy will have their badge confiscated by event personnel and will be asked to leave the conference.

No one under the age of 18 is permitted at any conference activity or session. Anyone under the age of 21 will not be able to attend the closing happy hour, even if accompanied by an adult.

Public sector attendees will be required to show their employer-issued government ID or other proof of government employment as well as a government-issued photo ID during check-in at the DevLive Level Up registration desks.
